I, the undersigned, on behalf of the Participant and for myself and my spouse, my family members, heirs, executors, administrators, representatives and any other third parties entitled to assert any rights by, through or under the Participant or any of the foregoing ("Releasers"), for good and valuable consideration and intending to be legally bound hereby agree as follows:

- Released Parties: I am signing this Agreement for the benefit of Final Four Tournaments, LLC, F4 Showbine LLC (collectively "F4") and Diamond Nation LLC, their members, coaches, directors, officials, supervisors, attorneys, trainers, spectators, vendors and sponsors, and the respective trustees, directors, officers, members, managers, agents, staff, volunteers, employees, heirs, executors and assigns of any and all of the foregoing.
- Assumption of Risks, Injuries and Losses: I am aware of the risks related to Participant's voluntary participation in a F4 related lacrosse event including, without limitation, games, tournaments, and combines. (collectively the "Event"). These risks are often unpredictable but are inherent in the game of lacrosse – a contact sport involving stick checks, body collisions and a hard rubber, high speed projectile. Risks include, but are not limited to, serious physical and/or emotional injury or disability, which may be temporary or permanent, and, in rare cases, death, and may be caused by field, weather, health or other conditions and/or the actions or inactions of Participant or others on or off the field of play, and may include the negligence of one or more of the Released Parties. I knowingly and willingly assume all such risk as well as responsibility for all personal and/or economic injuries, losses, damages, costs and expenses of any kind or nature, whether known or unknown, which Participant (or any Releaser) might sustain in connection with the Event (collectively, "Injuries and Losses"), and hereby consent to Participant's participation despite the risks. I authorize Released Parties to take any necessary action, in their best judgment under the circumstances, to help Participant in any urgent or emergent situation.
- Release and Covenant. I fully and forever give up, release and discharge the Released Parties from and against all claims or causes of action for Injuries and Losses, which Participant (or any Releaser) has, may have had, or may in the future have regarding or relating in any way to the Event. I covenant not to sue any Released Parties for any Injuries and Losses and agree to reimburse, indemnify and hold harmless each Released Party from and against all damages, losses, settlements, liabilities, costs and expenses (including court costs and reasonable attorneys' fees) incurred, suffered or sustained by any Released Party which arise from or are attributable to Participant's participation in the Event or incident or enforcement of this Agreement.
- I HAVE READ THIS AGREEMENT AND UNDERSTAND I AM GIVING UP IMPORTANT LEGAL RIGHTS. I HAVE EITHER CONSULTED AN ATTORNEY OR KNOWINGLY OPTED NOT TO DO SO. I HAVE AUTHORITY TO SIGN THIS AGREEMENT ON BEHALF OF THE PARTICIPANT AND THE RELEASERS. If any provision of this Agreement or the application thereof is deemed to be invalid or unenforceable, the remainder hereof shall not be affected thereby and shall be enforceable to fullest extent permitted by law.
